### Approval of Proposed Agenda

Chair Fowler asked if there were objections or additions to the agenda. The agenda was approved with no modifications.

### Approval of August 25, 2022, KSSC Meeting Minutes

Chair Fowler referred to the August 25, 2022, KSSC meeting minutes. Vice-Chair Sexton moved to approve the minutes. Mark Dupree seconded the motion. The motion carried, and the minutes were approved.

### Reimagining the Sentencing Guidelines – A Pennsylvania Perspective on Comprehensive Review

Executive Director Scott Schultz introduced Mark Bergstrom, Executive Director of the Pennsylvania Commission on Sentencing, and Rhys Hester, J.D. Ph.D., Professor, Clemson University.

Executive Director Mark Bergstrom and Professor Rhys Hester presented *Comprehensive Review of Sentencing Guidelines* and discussed sentencing guidelines and offender criminal history scoring comparisons between Kansas and Pennsylvania.

Jessica Domme requested that KSSC staff provide additional data at the next KSSC meeting.

### KSSC Educational Outreach Update

Francis Givens, Special Projects Manager, presented KSSC Educational Outreach Update and discussed the trainings provided and upcoming webinars.

### **Emerging Issues & Future Directions: SB 123 Raft Diversion Program**

Kira Johnson, LMLP, SB 123 Program Director, presented the *Emerging Issues & Future Directions: SB 123 Raft Diversion Program.* Ms. Johnson provided an update on the Program, discussed trends, changes, and reported that the SB 123 Fall Conference would be held on October 18, 2022.

### Incentivizing Probation Roundtable and the Possible Role of 2021 HB 2084

Executive Director Scott Schultz welcomed and introduced the roundtable participants, Honorable Tyler Roush, Sedgwick County District Court; Robert Sullivan, Director of Johnson County Community Corrections; Shelly Williams, Director of Riley County Community Corrections; and Spence Koehn, Office of Judicial Administration.

Executive Director Schultz moderated the roundtable discussion and reviewed 2021 HB 2084 and K.S.A. 21-6608, allowing courts to modify sentences for misdemeanors and felonies. Topics discussed are as follows:

- General probation modification practices in jurisdictions, including what works, what doesn't work, and ideas for reform.
- Is a mandatory statute necessary when K.S.A. 21-6608 already exists?
- Is a valid alternative an educational effort for offender supervising officers and offenders without a need for statutory guidance?
- If KSSC adopted proposed legislation like 2021 HB 2084, how could it be improved?

### <u>Wherefore Art Thou Romeo and Juliet? – A Judicial Council Perspective on Unlawful Voluntary Sexual Relations</u> in KSA 21-5507

Christy Molzen, J.D., Staff Attorney, Kansas Judicial Council, presented the Judicial Council's recommendations relating to K.S.A 21-5507, unlawful voluntary sexual relations, and reported the Judicial Council has twice requested legislation that would amend K.S.A 21-5507 by expanding the age range of minors to which the statute applies and reducing the penalties for voluntary sexual conduct between minors. The legislation was drafted as part of a study of the Kansas criminal code's sex offense structure and related registration requirements for juveniles and adults, which was requested in 2018 and completed in 2020. That study was conducted by the Judicial Council Sex Offenses and Registration Advisory Committee.

Part of the original study request from Representatives Russell Jennings and Blaine Finch asked the Council to review the 2018 HB 2738, a bill introduced at the request of Representative Highberger, that would have amended K.S.A 21-5507 to reduce penalties and, in some cases, decriminalize voluntary sexual conduct between minors who are close in age. The Committee agreed with the rationale behind the 2020 HB 2473 but offered an alternative proposal, first introduced as 2020 HB 2473 and the following year as 2021 HB 2347.

### KSSC Legislative Committee Recommendations & Discussion

Chair Fowler reported on the KSSC Legislative Committee meeting held to discuss and recommend 2023 KSSC legislative proposals. Chair Fowler presented the Committee's recommendations to adopt and continue supporting KSSC's 2022 legislative proposals.

#### **Review & Discussion of proposed Legislation**

Chair Fowler referred to the handout *Review & Discussion of Proposed Legislation* and reviewed the process in adopting KSSC's 2023 legislative proposals.

Executive Director Scott Schultz referred to the handout *Review & Discussion of Proposed Legislation* and provided an overview of each legislative proposal recommended by the KSSC Legislative Committee.

### Allowing Earned Discharge and Limiting the Maximum Term for Probation. (HB 2084)

Jessica Glendening moved to approve and continue supporting the reintroduction of HB 2084 with the following amendments.

- 50% callback discretionary rather than mandatory.
- Replace 7d/mo. probation credit with the court service officer's recommendation as recommended in the Research-Based Incentives Subcommittee's Report to the Kansas Criminal Justice Reform Commission.

Jermaine Wilson seconded the motion. The motion carried.

### Modifying the Penalties for Sexual Contact between Certain Juveniles and Excluding such Juveniles from Offender Registration. (2020 HB 2473)

Vice-Chair Sexton moved to support the Judicial Council if 2020 HB 2473 is reintroduced. Jessica Glendening seconded the motion. The motion carried.

# Extending Terminal Medical Release to Inmates in the Custody of KDOC with a Condition Likely to Cause Death within 120 days. (<u>HB 2030)</u>

Vice-Chair Sexton moved to approve and continue supporting the reintroduction of HB 2030. Pat Colloton seconded the motion. The motion carried.

### Increasing Good Time and Program Credit for Certain offenders. (HB 2031)

The Commission discussed amending HB 2031 to increase only 5% good time (15% to 20% and 20% to 25%) and will continue the discussion at the next KSSC meeting upon receiving metrics on those inmates who lose credit.

# Allowing Courts to Prohibit Possession of a Firearm in a Temporary Custody Order Pursuant to the Care and Treatment Act for Mentally Ill Persons. (<u>HB 2095)</u>

Pat Colloton moved to table the approval of HB 2095 until the next meeting to determine whether NCIC can post prohibition of temporary hearing and requested a new language be provided. Vice-Chair Sexton seconded the motion. The motion carried.

### Aligning Felony Loss Thresholds with Theft. (SB 5)

Jessica Glendening moved to approve and continue supporting the reintroduction of SB 5. Jessica Domme seconded the motion. The motion carried.

### Justice Reinvestment Initiative in Kansas

Executive Director Scott Schultz introduced Jennifer Kisela, Program Director, State Initiatives, Council for State Governments (CSG) Justice Center.

Ms. Kisela presented *Justice Reinvestment Initiative in Kansas*, a data-driven approach to improve public safety. She reported information on the following topics:

### <u>The KSSC Electronic Journal Entry Project – The Future Today with Criminal Justice Data in Kansas</u>

The KSSC has recently entered into an agreement with Domo, Inc. to provide software development services to digitize the agency's journal entry forms. Executive Director Scott Schultz introduced Tanner Garrett, Product Manager - Custom Apps, Domo, Inc. Mr. Garrett presented the *Electronic Journal Entry Project*, discussed the data app platform implementation, and demonstrated the KSSC Electronic Journal Entry features.

### Lessons in Redemption

Jermaine Wilson, Mayor Pro-Tem of Leavenworth, Kansas, and KSSC commission member, provided his inspiring story, *Lessons in Redemption*." Mayor Wilson reflected on how he transformed from a convicted drug dealer to a Kansas mayor and continues to be a community leader in many areas.

### Changing Penalties for Severity Level 5 Drug Crimes. (HB 2139)

Vice-Chair Sexton moved to approve and continue supporting the reintroduction of HB 2139. Representative Highberger seconded the motion. Jessica Domme voted no. The motion carried.

### Expand SB123 Substance Abuse Treatment to Severity Level 7-10 Nondrug Offenders. (2021 HB 2128)

Pat Colloton moved to table the approval of 2021 HB 2128 until the next meeting and requested additional language be provided for the WRNA and LS/CMI criteria to be tied to high risk on the substance abuse domain of the assessments rather than the current SB 123 criteria. Jessica Glendening seconded the motion. The motion carried.

# Removing Drug Offenders from the Registration Requirements of the Kansas Offender Registration Act and Removing the Felony Penalty for Multiple Nonpayments of Fees Under the Act. (<u>HB 2092)</u>

No Action was taken.

# Modifying how Certain Prior Convictions are Counted for the Special Sentencing Rule Related to Possession of a Controlled Substance and Providing Concurrent or Consecutive Sentencing for Persons Convicted of New Crimes while on Release for a Felony. (HB 2081)

Representative Highberger moved to approve and continue supporting the reintroduction of HB 2081. Jessica Glendening seconded the motion. The motion carried.
